**MOTION AND APPLICATION FOR TEMPORARY RESTRAINING ORDER  
WITHOUT NOTICE AND PRELIMINARY INJUNCTION**

Upon verified complaint filed herewith, the Plaintiffs above, John B. Curley, as Chairman of the Lake County Republican Central Committee and as a registered voter, and Jim B. Brown, as member of the Lake County Board of Elections and Registration, and as a registered voter, by counsel, now file and present this Motion and Application for Temporary Restraining Order and Preliminary Injunction, and in support thereof says:

1. unless restrained and enjoined by this Court, the Defendants will establish unauthorized and the illegal satellite absentee voting offices, and commence absentee voting thereat, as described and complained of in said verified complaint;


2. unless restrained and enjoined by this Court, the unlawful conduct of the Defendants, complained of in said verified complaint, will continue;

3. unless restrained and enjoined by this Court, the threatened dilution of votes generally, and in particular, those of the Plaintiffs, as described and complained of in said verified complaint, will occur and continue; and,


4. said verified complaint, heretofore filed in this cause of action, is hereby incorporated by reference and made a part hereof.
