

**ORDER GRANTING UNOPPOSED MOTION TO DISMISS THE  
INDIANA ELECTION COMMISSIONERS WITH PREJUDICE**

Plaintiff Indiana State Conference of the NAACP has filed an unopposed motion to dismiss, with prejudice, the Defendant Commissioners of the Indiana Election Commission. The motion was filed pursuant to an agreement among the parties reflected in paragraph I.B of the Settlement Agreement in this matter [doc. 143-1], approved by this Court on August 25, 2011 [docs. 151 & 152]. Having considered this motion, the Court hereby finds that it should be GRANTED.

Accordingly, it is ORDERED that Defendants S. Anthony Long, Daniel A. Dumezich, Sarah Steele Riordan, and Bryce H. Bennett, Jr. (automatically substituted in for Defendant Thomas E. Wheeler, pursuant to Fed. R. Civ. Pro. 25(d)) are dismissed with prejudice from this action.
